After examining Naturepedic products, reviewing their website and certifications, and speaking with the owners and staff, I have concluded that the products listed in this Materials Disclosure Statement are made from toxic-free materials.

Therefore, I hereby register the product in this Materials Disclosure Statement to the Zero Toxics Product Registry as "toxic-free" and unlikely to do harm to the consumer under normal use.

DISCLAIMER

The purpose of this Materials Disclosure Statement is simply to make known that the products named are unlikely to do harm to the user of the products, under normal use, to the best of my knowledge. I speak not as a scientist or toxicologist, but as an educated consumer and experienced toxic-free product expert. I am not a medical doctor and I am not giving medical advice. My intent in providing this Materials Disclosure Statement is simply to offer you information that may help you as you make your own choices to eliminate toxic exposures from your home.

MAKING MATTRESSES & MATTRESS ACCESSORIES WITHOUT TOXIC CHEMICALS IS AT THE VERY HEART OF NATUREPEDIC

The creation of a mattress that is free from questionable chemicals has, in fact, been at the heart of Naturepedic from the very beginning. Founder Barry A. Cik is a Board Certified Environmental Engineer who has been chasing toxic chemicals for more than forty years. He is also a Certified Hazardous Materials Manager and a Certified Diplomate Forensic Engineer, and author of a textbook for Government Institutes on environmental assessments.

In 2003, Barry was sent to a juvenile furniture store by his wife to buy a crib mattress for their first grandchild. When he walked in, Barry quickly realized that *every single crib mattress was made from polyurethane foam and vinyl*, both materials he knew contained toxic chemicals. His response to this was, "My grandfather slept on straw, and I'd rather put my grandchild on straw than on these materials."

Barry looked far and wide for a crib mattress that he was willing to let his grandchild sleep on, and couldn't find one. This led Barry and his family to make a crib mattress out of materials that would be safer for their own grandchild, and Naturepedic became the first manufacturer of a waterproof organic crib mattress.

From these beginnings, Naturepedic went on to make mattresses without toxic chemicals for the whole family. Naturepedic today makes a full line-up of mattresses and foundations for kids and adults, including high-end luxury mattresses and foundations, that are all focused on combining luxury and comfort with organic and non-toxic designs.

The owners of Naturepedic believe, as I do, that potentially toxic chemicals need to be eliminated from all consumer products, for the health and safety of all family members.

In addition to making mattresses and foundations that are free from potentially harmful chemicals, Barry has been active in promoting reform of Federal laws regarding chemical safety, in particular the Toxic Substances Control Act (TSCA). He was invited to testify to U.S. Congress in 2014 to help jumpstart Congressional discussions surrounding TSCA and the essentially uncontrolled uses of the 84,000 chemicals currently "legal" in the U.S. Although TSCA was updated in 2016, progress was extremely limited and Barry feels there is much more to be done.

I have spent many hours over a period of more than 10 years talking with Barry and other staff, and have visited their GOTS-certified facility. I have watched them take their toxic-free materials and use them in innovative ways to make mattresses. This company understands the issues and is dedicated to eliminating toxics in their products and in the world.

While other mattress and foundation brands may be made with some organic materials, Naturepedic has gone all the way to being certified by the [Global Organic Textile Standard \(GOTS\)](#) as a **certified organic mattress and foundation manufacturer and facility**. This means that ALL the materials and processes *and the facility* in which Naturepedic mattresses and foundations are made meet the GOTS organic and nontoxic standards.



In addition to being certified organic, the GOTS certification also indicates that the materials used to make Naturepedic mattresses and foundations are validated to be [non-GMO](#).

All Naturepedic mattresses and foundations are certified organic per GOTS.

Naturepedic has complete control over what materials are used, what the work environment is like, how their mattresses and foundations are stored and shipped, and every other aspect of production.

MATERIALS DISCLOSURE

The materials are divided by function, so the user can get a feel of their volume and importance, where the user might have direct contact with them, and where the materials would be inside and away from the user. Some materials are present only in minute amounts, such as thread or a bit of padding or a clip. These are included because even though they may be insignificant to most people, for those who are individually sensitive to these materials, their presence may be highly problematic. Evaluation of toxicity for the purpose of this statement is based on toxicological data and not individual tolerance. Use your own judgement to determine what is right for your own body.

“Functional Accessories” are things added that have a specific purpose in order to make the product useful. Without them, the main materials don’t function as the useful product. In this Materials Disclosure Statement they are called GOTS NONTOXIC ACCESSORIES and meet the GOTS requirements.

PACKAGING

All Naturepedic mattresses and foundations are protected from exposure to toxic chemicals during shipping by being wrapped in **GOTS-Approved Food-Grade Polyethylene**. The wrapped mattress and foundation is then placed in a cardboard box for shipping.

No toxic chemicals or other unacceptable materials prohibited by GOTS are permitted for use in Naturepedic products.

MATERIALS NOT USED

Naturepedic does not use the following materials commonly used in mattresses and foundations:

- Polyurethane foam
- Memory foam
- Soy foam, eco foam, biofoam, plant-derived foam (all of which are mostly polyurethane foam)
- Chemical flame barriers or other flame retardant chemicals
- Latex
- Vinyl and associated phthalates
- Perfluorinated compounds
- Antimony
- Formaldehyde
- Pesticides
- GMOs
- Glues/adhesives

Naturepedic products eliminate most of the petroleum-based materials or components commonly used in mainstream mattresses and foundations, with the exception of some GOTS approved materials that are required to make a quality mattress or foundation.



Naturepedic mattresses and foundations are “handmade” in the sense that actual people are making the mattresses, foundations, and bedding. That said, there are also machines that make their hand work easier, such as sewing machines and machines that make coils. But the basic assembly of the mattresses and foundations is done by hand.



All Naturepedic mattresses and foundations are made in the USA of domestic and imported fiber, fabrics and other components. All fibers, fabrics, and other materials that can be sourced in the USA are sourced in the USA.
